In continuation to this office letter No.MCI-34(41)(E-51)/2019-Med./171916, dated 08/02/2019 and your letters dated 21.02.2019, 04.04.2019 and 10.05.2019 furnishing required undertaking/Bank Guarantee, I am directed to convey the formal permission of the Board of Governors for establishment of a new medical college at Mittapalli (V), Siddipet (M) Medak District, Telangana in the name and style of "Surabhi Institute of Medical Sciences" with annual intake of 150 MBBS students for the academic year 2019-2020 under Section 10A of the Indian Medical Council Act, 1956.

2. This permission of the Board of Governors in supersession of the MCI accorded initially for a period of one year and will be renewed on yearly basis subject to verification of achievement of annual targets as indicated in your scheme. This process of renewal of permission will continue till such time the infrastructure and expansion of hospital facilities are completed as per norms of Medical Council of India and the college is recognized. The next batch of students shall be admitted only after obtaining permission of the Board of Governors in supersession of the MCI.
